Foundry is on its way to our community! Foundry is a province-wide network of integrated health and wellness services for young people aged 12-24 and their caregivers. Foundry qathet will bring together existing services to reach young people before they are in crises. Foundry gathet will be hosted by Youth & Family, a long-standing local non-profit.

The five core services offered are:

- 1) Mental health care
- 2) Substance use services
- 3) Physical and sexual health care
- 4) Youth and family peer supports
- 5) Social services

The need for early intervention for youth is urgent. In Canada, over 80% of problematic substance use begins by the age of 20 and 70% of mental health concerns begin before the age of 24. But fewer than 25% of youth are accessing the care they need.

We are fundraising for the capital phase of Foundry qathet (renovations, equipment & furnishings). Location to be announced soon! Once open, Foundry centres receive guaranteed operational funding from the province. Foundry is connection, care, and support for all of life's challenges! Follow along at:
